Drawings and Specifications for the above noted project and the work covered thereby are herein modified as follows, and except as set forth herein, otherwise remain unchanged and in full force and effect:

GENERAL NOTES:

Item 2-1: Elevator Access Note

The existing elevator within Schrenk West hall may be used for construction deliveries during construction. Elevator will remain in use for the occupants during construction, contractor to coordinate use with project manager.

SPECIFICATIONS:

Item 2-3: Table of Contents

Replace existing first Table of Contents page with new attached Table of Contents Page.

Item 2-4: General Requirements

Add the following two attached sections:

- Bidders Statement of Qualifications
- Supplier Diversity Forms.

Item 2-5: Section 1.A - Bid for Lump Sum Contract

Refer to Subparagraph 4.a - Contract period. Remove the sentence "*Bidder agrees to complete project within two hundred forty (240) calendar days from receipt of aforementioned documents.*" Replace with the following:

“Bidder agrees to complete project within two hundred sixty (260) calendar days for base bid scope of work. Bidder agrees to give thirty (30) days additional for each of the (3) alternates that are accepted from receipt of aforementioned documents.”

Item 2-6: 07 84 46 – Fire-Resistive Joint Systems

Refer to paragraph 1.5 Quality Assurance. Add the following paragraph.

- A. Installer Documentation: General Contractor shall engage a single Firestop Contractor to perform all firestopping. Submit document from firestop manufacturer wherein manufacturer recognized, i.e. approves installer for said manufacturer’s firestop products.

Item 2-7: 09 91 23 – Interior Painting

Refer to paragraph 3.7 Paint Schedule. Add the following painting system for all Glazed CMU/Brick in lieu of system CMU-3I for these areas. All hue references shall relate with the finishes legend on sheet IF1.30. Additional information pertaining the scope of this coating system is found on sheets IF1.01 and IF1.02.

D. System GCMU-301 for application on Interior Glazed CMU (GCMU):

1. Eggshell Water-based two-component Acrylic Polyurethane Finish: 1 intermediate coat and 1 finish coat over primer.
2. Waterborne Primer/Sealer: Waterborne primer coating used on interior glazed CMU under a waterborne acrylic urethane finish.
 - a. Thickness: Apply as many coats as necessary to produce a uniform substrate appearance. Do not exceed manufacturer’s recommended coverage rate. Allow to dry prior to application of subsequent coats.
 - b. Scuffmaster: Master Coating Technologies—Primemaster Bonding Primer.
 - c. Or equal, if and as specifically approved by Architect by Addendum during bidding period.
3. Intermediate Coat— Eggshell Water-based Acrylic Polyurethane: Opaque coat for use over primed, interior glazed CMU surfaces: Scrub Test = 8,000 scrub cycles per ASTM D 2486. Finish/Sheen—Eggshell. Color; see legend:
 - a. Application: Spray or roll finish to completely cover primer and according to manufacturer’s written instructions. Apply in a continuous, even film at manufacturer’s specified coverage rate.
 - b. Scuffmaster: Master Coating Technologies—ScrubTough ST10416.
 - c. Or equal, if and as specifically approved by Architect by Addendum during bidding period.
4. Finish Coat— Eggshell Water-based Acrylic Polyurethane: Opaque coat for use over intermediate coat, for application on interior glazed CMU surfaces. Scrub Test = 8,000 scrub cycles per ASTM D 2486. Finish/Sheen—Eggshell. Color; see legend:
 - a. Application: Spray or roll finish to completely cover primer and according to manufacturer’s written instructions. Apply in a continuous, even film at manufacturer’s specified coverage rate.
 - b. Scuffmaster: Master Coating Technologies—ScrubTough ST10416.
 - c. Or equal, if and as specifically approved by Architect by Addendum during bidding period.

Item 2-8: 10 11 00 – Visual Display Surfaces

Refer to subparagraph 2.2.A. MB-(X) – ‘X’ indicates markerboard sizes, see architectural plans for locations and interior sheets for sizes.

Item 2-9: 12 35 53 – Metal Laboratory Casework

Refer to subparagraph 2.8.E.1. Remove reference to E07281, Type E07111, Type 07021 and replace with “Type E07261 and E07271

Item 2-10: 22 05 29 & 23 05 29 – Plumbing & Mechanical Hangers and Supports

Refer to paragraph 2.7.E & 2.8.E, respectively. Alter firestopping note to say the following:

“Per university standard, all fire-rated sealants and firestops shall be installed by a certified firestop contractor. Reference Spec Section 07 84 46 for further information.”

Refer to paragraph 2.1.E. Add Engineered Air as an acceptable manufacturer.

Refer to Infill Details #1, #2, #3. Note that flowable fil may be used in lieu of sand for filler below new concrete slab.

Replace existing IF1.30 with new attached IF1.30. Note updated Finish Equipment.

Item 2-20: LF0.20 – Laboratory Casework Schedules & Elevations

Refer to type MW – LAB METAL WALL CABINET. Remove reference to “sliding” glazed doors and replace with “swinging” glazed doors.

Item 2-21: LF0.30 – Laboratory Casework Sections & Elevations, Laboratory Details

Replace existing LF0.30 with new attached LF0.30. Note updated casework section details and new Casework Section for adjustable shelving.

Item 2-22: M0.00 – Mechanical Abbreviations, Symbols, and Notes

Refer to added note regarding temporary conditioning. Reference general sheets G1.11 and G1.12 for hatched phasing plans.

Item 2-23: M0.01 – Ground Floor HVAC Demolition Plan – Area A

Refer to revised demolition plans for changes to the G36 area. Existing ductwork has already been removed and will not fall under scope of project. See demolition of ductwork in stairwell to prepare for new FCU installation.

Item 2-24: M0.02, M0.03 – Ground Floor HVAC Demolition Plan – Areas B & C

Refer to revised demolition plans for removal of ductwork in stairwell to prepare for new FCU installation.

Item 2-25: M1.01 – Ground Floor HVAC Plan – Area A

1. Refer to changes to the G36 laboratory area. General exhaust box has been added and ducted to new main.
2. See added FCU in the stairwell.
3. Minor modifications to diffuser locations for ceiling grid coordination.
