
1020 S. EL CHAPARIRAL AVE.

- 1 INSTALL 9" STRAW WATTLES IN EXISTING DRAINAGE DITCH PRIOR TO ANY WORK TAKING PLACE ON EL CHAPARRAL AVE. WATTLES SHALL REMAIN IN PLACE UNTIL FINAL GRADING WORK IS READY TO BEGIN.
- 2) PRIOR TO FINAL GRADING WORK, INSTALL 9" STRAW WATTLE NEAR END OF GRADING DISTURBANCE. WATTLE SHALL REMAIN IN PLACE UNTIL RESTORATION BID ITEM IS SATISFIED.
- 3 PRIOR TO GRADING, CONTRACTOR SHALL POTHOLE EXISTING FIBER OPTIC LINE IN SEVERAL LOCATIONS WITHIN PROPOSED GRADING AREA TO ESTABLISH DEPTH OF LINE. AREAS WHICH WILL HAVE 2' OR LESS OF COVER AFTER FINAL GRADING SHALL BE NOTED. CONTRACTOR SHALL BE RESPONSIBLE FOR COORDINATING WITH CENTURYLINK OR CENTURYLINK'S CONTRACTOR FOR FIBER TO BE LOWERED WHERE NEEDED.
- (4) GRADE AREA PER THIS PLAN AND GIVEN ELEVATIONS. GRADING SHALL BE BLENDED INTO THE EXISTING SURFACE USING A 3:1 SLOPE SOUTH OF THE GRADE BREAK.
- (5) EXISTING DITCH LINE SHALL BE SHIFTED AND DEEPENED FROM ITS CURRENT LOCATION.
- 6 AFTER FINAL GRADING IS COMPLETE, ALL DISTURBED AREAS SHALL BE RESTORED WITH SEED, LIME, FERTILIZER, AND BE COVERED WITH PROPEX LANDLOCK S2 EROSION CONTROL BLANKET OR APPROVED EQUAL. ADDITIONAL 9" STRAW WATTLES SHALL BE INSTALLED IN THE PROPOSED DITCH. WATTLES SHALL REMAIN IN PLACE UNTIL GRASS DENSITY PER RESTORATION BID ITEM IS SATISFIED.
- 7 EXISTING REBAR PROPERTY MARKING WILL NOT NEED TO BE REINSTALLED.


